Subject: Freedom of Information Request

You asked for the following information:

Please provide the number of police pensions in payment in England and Wales by Force Area.

Our answer is as follows:

The most up to date pensions in payment data we hold is from 31 March 2016. On this date there were 152,030 pensions in payment to pensioners or their dependants if they were deceased. A breakdown of these numbers by force can be found below.

Please note that the figures below are based on data collected for use in the 2016 actuarial valuation of the police pension schemes. The data has been checked and adjusted as appropriate to allow for any known omissions or inaccuracies which are material to the 2016 actuarial valuation. These checks do not represent a full independent audit of the data supplied and do not by themselves confirm or guarantee the overall quality or correctness of the data. In particular, the analysis relies on the general completeness and accuracy of the data supplied by police forces without independent verification. The data has been through the majority of the valuation data checking process but has not yet been formally signed off for use in the 2016 valuation.

We trust that this summary is sufficient to resolve your query.
